Contents of the package

Check the following items:

- GateManager unit
- Power supply 36W
- Ethernet Cross-over cable

POWER

Use the enclosed power supply attached to a 100-240 V " 50-60 Hz wall outlet.

Ethernet ports

Ports are 10/100/1000 Mbps. Use standard CAT5 cables or higher to connect to a switched network. The ports are auto-sensing cross over, so if connecting directly to a PC for configuration, you can use the enclosed cross-over cable or a standard.

The WAN port is used for normal operation. The LAN port is used only for debugging and special configurations.

USB Ports

USB ports are used for backup and restore and/or connection of an optional external USB modem used for SMS alerts and/or login authentication.

NOTE: Currently only supported locally installed USB SMS modem is Huawei model MS2131 (Secomea P/N 27024), but SMS support can also be obtained by configuring an external SMS Gateway. Refer to the guide "Configuring SMS Gateways on GateManager"

The port supports a USB 2 compliant USB flash drive formatted for FAT 32. Recommend size is


